The NAME Board of Directors voted on March 12, 2009 in a 'first reading' to adopt changes to the organization's Bylaws that increase the terms of office of Secretary and Treasurer from one to two years. Lewin Interviews and the Mandated Report to Congress

Per the Supplemental Appropriations Act of 2008, CMS contracted with an independent organization to produce a report on four Medicaid regulations currently under congressional moratoria, including CMS 2287 which impacts school-based Medicaid claiming. The Lewin Group was chosen to produce the required comprehensive report on the prevalence of the problems that these four regs were intended to address, strategies to address those problems, and the impact of the regs on each State and the District of Columbia.
