## Proposed Elimination of Administrative Claiming and Transportation Services

The President's 2007 budget would, through administrative action, prohibit federal reimbursement for IDEA-related school-based administration and transportation costs. Health and Human Services (HHS) estimates that the proposal would save \$615 million in federal dollars in FY2007 and \$3.645 billion in federal dollars over the FY2007-FY2011 period. Many school divisions rely heavily on this reimbursement and the elimination of Administrative claiming and transportation services could be devastating nationwide.

The American Association of School Administrators (AASA) worked with Senator Edward Kennedy (D-MASS) and Representatives John Dingell (D-MI) and Ed Whitfield to Develop S 3705 and HR 5834, Protecting the Children's Health in School's Act of 2006 . S 3705 and HR 5834 amend the Title XIX of the Social Security Act to clarify the ability of schools to claim for administrative and transportation cost associated with services provided to students with disabilities and low -income students.

Over 60 state agencies, state associations and organizations have contacted the Secretary of Health and Human Services opposing the elimination of Administrative Claiming and Transportation Services. ## NAME is Tax Exempt!

The IRS issued a letter approving NAME, Inc. as a 501 (c) (3) tax exempt organization in early July 2006. Receiving the letter culminated a seven month process and is one more piece in our long-term strategic plan. In the future, this will also allow NAME to qualify for potential research grants that are sometimes only available to tax exempt organizations.

# IDEA Regulations Regarding Parental Consent

The Regulations for the Individuals with Disabilities Education Improvement Act (IDEA 2004) were published in the Federal Register on August 14, 2006. They are now official and must be implemented by State and Local Education Agencies by October 13, 2006. Section §300.154 (D) (2)(iv) on parental consent was amended. The following is the discussion of the revision by the Department of Education: "..... to clarify that parental consent is required each time a public agency seeks to use the parents public insurance or other public benefits. We do not believe that it would be appropriate to include a provision permitting waiver of parental consent in this circumstance even where a public agency makes reasonable efforts to obtain the required parental consent. However we agree with the commenter that a public agency could satisfy parental consent requirements under FERPA and section 617 (c) of the Act if the parent provided that required parental consent to the State Medicaid Agency and the consent satisfied the part B definition of consent in §300.9."

NAME and other organizations are currently analyzing this revision and recommendations regarding its implementation will be released in the near future.

## Membership Stats

As of the end of July 2006, the NAME organization has 238 members. Of these, there are 44 'voting' members, which include 24 from the state Medicaid agencies and 20 from the Education agencies in 35 different states. The remaining members are from other state or LEA staff and other companies/agencies
