New Medicaid Action Group

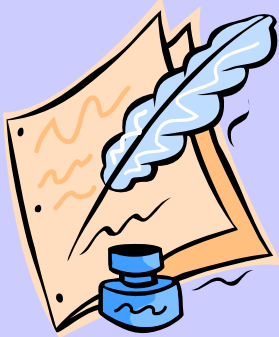

Many school districts depend on federal Medicaid funds to support health related services provided in special education, the Early Periodic Screening, Diagnostic, and Treatment (EPSDT) program, and other health care services delivered in the school setting. The scope of services runs from dental clinics, health screenings, and a wide range of therapeutic services. For many children, their only access to health programs is through the schools, and federal Medicaid dollars help LEAs [local education agencies] offset the cost of providing that access.

In response to perceived threats to school health programs supported by federal Medicaid funds a group of school districts, led by the Los Angeles Unified School District and Baltimore City Public Schools, has formed a loose coalition to share information and coordinate strategy. The group is called **LEAnet**.

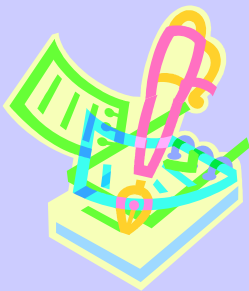
The 2005 Deficit Reduction Act, signed by President Bush in February, reduces funding for targeted case management services, imposes additional requirements for third party liability, and imposes nearly insurmountable obstacles to the Medicaid application process for millions of American families, and a potential reduction in the federal match for rehabilitation services. In addition, the 2007 federal budget calls for the complete elimination of federal dollars for school-based administrative outreach and transportation and additional restrictions of TCM. Together, these two initiatives will remove millions of federal Medicaid dollars from school district budgets, negatively affecting the delivery of critical health services to children.

The U.S. Department of Health and Human Services' Centers for Medicare and Medicaid Services (CMS) has indicated in discussions with various state Medicaid directors that CMS intends to move forward with cuts without further Congressional action and, in some cases, without formal rulemaking. This would eliminate input from both Congress and the education community.

Special April Board Meeting

Cathy Griffin, NAME President called for a special meeting of the NAME Board of Directors on April 6th to discuss current and proposed federal initiatives that may or will affect the ability of schools across this country to deliver health care services to children. The meeting began by focusing on the following questions:

- What is NAME's role?
- How do we carry out this role?
- Who are our key partners?
- Who is our target audience?
- What exactly are we "protecting?"

These questions made for impassioned discussion and yet we actually found the answers came with relative ease. The following are some statements summarizing the discussion:

- NAME can provide awareness and build alliances by providing information and facts to dispel myths and showcase the accountability that occurs in the majority of schools.
- NAME will develop communication tools such as white papers, talking points, letter templates, data and analyses of data, and administrative guidelines for use by states and LEAs in developing or revising their Medicaid in schools programs.
- NAME wants to assist to develop better guidance and protocols that will maintain the integrity of the Medicaid program in the context of an educational setting in an effort to meet appropriate standards for all stakeholders and to ensure that children have access to necessary health care services and good health outcomes.

Once we all agreed on our responsibilities as an organization, the next task was to develop a work plan and ask board members to volunteer to take upon themselves significant projects. Currently, board members are:

- Reviewing the Deficit Reduction Act, along with related analyses, to determine the direct impact on children in schools.
- Determining possible implications of the third party liability rule on accessing Medicaid in schools.
- Deciding if/how changes to Target Case Management will affect children in schools.
- Determining how/if NAME will comment on any rule making coming out of CMS related to Medicaid in schools.
- Evaluating the possible repercussions if states revise how they administer EPSDT.

As you can see, we have our work cut out for us. If any of you have completed some of your own analysis, or if you are aware of some excellent pieces, please contact or forward it to your regional board representative or one of the officers.

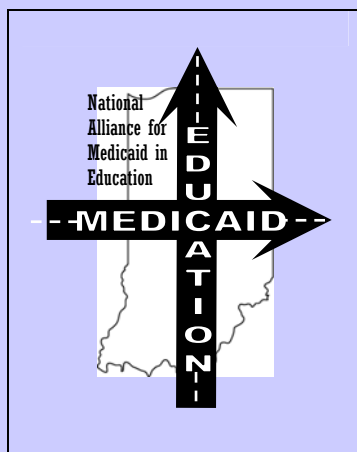
Indianapolis, Indiana

Conference activities will again include the regional round table discussions for each of the 10 CMS regions. This year, attendance at these round table discussions will be limited to state Medicaid agency, state education agency and local education/school employees.
